RETIREE HEALTHCARE WITH NO-COST PRESCRIPTION DRUG COVERAGE

1199SEIU members who have both the 1199 National Benefit Fund and the Pension Fund receive no-cost retiree healthcare for the rest of our lives when we retire at 65 with 10 years of service or at 62.5 with 25 years of service based on date of hire from our institution. This includes no-cost prescription drug coverage. Many of our spouses are also eligible for nocost retiree healthcare.
